



## **I. Supervision.**

3. The April 2, 2008 Stipulation and Agreement identified and approved Thomas Peterson, M.D., to act as the primary supervising physician for Dr. Giroux during his re-entry to practice. In addition, Allan Ramsay, M.D., Robert Luebbers, M.D., and John Saia, M.D., were approved as secondary supervising physicians for Dr. Giroux. Dr. Peterson now has requested the Board's approval of Candace Fraser, M.D., to act as an additional supervising physician for Dr. Giroux at the Family Medicine Health Care Service.

4. The Board's South Investigative Committee, to which this matter is assigned, has reviewed the c.v. of Dr. Fraser and has found her qualified to act as an additional secondary supervisor for Dr. Giroux. The Committee has recommended that Dr. Fraser be approved by the Board of Medical Practice to carry out this responsibility. In this regard, the April 2, 2008 agreement between Dr. Giroux and the Board requires a minor amendment.

## **II. Amendment.**

5. Paragraph 16 of the April 2, 2008 Stipulation and Agreement, as approved by the Board of Medical Practice, shall be amended to add the name of Candace Fraser, M.D. to the list of physicians designated to act as secondary supervising physician for Dr. Giroux during his re-entry to the practice of medicine, for the purposes set forth in Paragraphs 15 through 26 of the April 2 agreement. In light of this recommendation by the Committee, the Board hereby approves Dr. Fraser for the purposes set forth by agreement of the parties.

6. Dr. Giroux agrees that he shall promptly provide a copy of his original Stipulation and Agreement to Dr. Fraser, as well as a copy of this amendment. By agreement of the parties, all other terms of the April 2, 2008 Stipulation and Agreement shall remain unchanged.
