would be voted out of Committee as introduced and that the Senate Health & Welfare Committee is considering "strike all" proposals that are substantially different from the original bills.

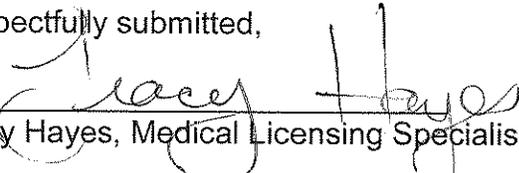
4. Next Regular Board meeting: March 2, 2016, 12 p.m., Gifford Medical Center, Randolph, Vermont.
