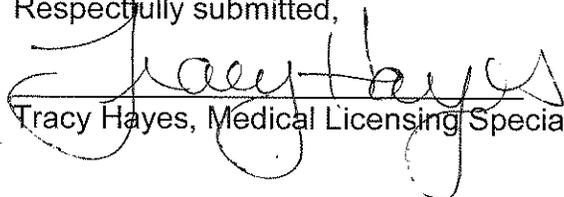
4. Next Regular Board meeting: April 6, 2016, 12 p.m., Gifford Medical Center, Randolph, Vermont.
